## 3. Action Arising from Previous Meeting

- c. We shall need an organizing chair to get plant donations and divisions, advertising (website, craigslist, NWGarden News, etc), pricing, and tags.
- d. We shall write an article for submission to the Seattle Times as a human interest story, volunteer project, fund raising feel good article to be published in the spring, prior to the plant sale. We will need pictures.

## 9. Project Report – Programs
